

The nomination committee's recommendations to the annual general meeting in BEWI ASA on 1 June 2023

The nomination committee in BEWI ASA has the following composition:

- Liv Malvik, Chair
- Roar Husby

The nomination committee has held regular meetings since the previous general meeting.

During this period, the committee has assessed the board's work and composition based on the competence needs of BEWI ASA, the company's situation, opportunities, and challenges. The nomination committee has contacted and encouraged the largest shareholders to provide suggestions, if any, relating to the composition of the board, and has also been in dialogue with the respective board members of the company who are up for election this year.

The company has had a continued positive development overall in the last 12 months. The nomination committee considers that the current board of directors functions well as a collegium, and that the board has broad and relevant expertise and a good understanding of the company's strategic challenges and opportunities.

For the general meeting of BEWI ASA on 1 June 2023, the nomination committee presents the following recommendations:

1. Election of members to the board of directors

The nomination committee recommends the re-election of the board members who are up for election in 2023. In addition, the nomination committee recommends that an additional board member be elected to the board of directors of the company. Thus, the nomination committee nominates Pernille Christensen as new board member.

Pernille Christensen was born in 1966 and has a degree in Business and Economics from the Norwegian School of Economics (NHH) with specialization in finance and financing control. Christensen has a varied and diverse background and has held various positions within the financial sector, including in the Alfred Berg funds, DnB Markets and Vesta. When Christensen started as investment director at Kverva AS during the autumn of 2021, she also had more than 25 years of experience from Carnegie Kapitalforvaltning, both as portfolio manager and investment director. Christensen possesses experience and expertise which, in the opinion of the nomination committee, will contribute well to the board of BEWI ASA.
